NOTICE

In pursuance of the notification issued by the Directorate of Higher Education, Assam, Kahilipara, Guwahati vide Letter No. 75718/11/2026(i) dated 12th June, 2026, the following guidelines are hereby notified for the information and necessary compliance of all concerned regarding the **Spot Admission** process for Undergraduate (UG) Programmes for the Academic Session 2026-27.

SPOT ADMISSION POLICIES, 2026

1. Spot Admission shall be conducted on **15th,16th and 17th June, 2026** against the vacant seats available in various programmes/subjects of the College.
2. Only those applicants who are duly registered in the Assam State Higher Education Admission Portal (SAMARTH) and fulfill the prescribed eligibility criteria shall be considered for Spot Admission.
3. Spot Admission shall be made strictly on a First-Come, First-Served basis, subject to availability of seats and fulfillment of eligibility requirements.
4. Preference shall be given to the Discipline Specific Course (DSC) opted by the applicant, subject to availability of seats in the concerned department.
5. For the purpose of subject allocation, due consideration shall be given to departments having full faculty strength so as to ensure effective academic administration and optimum utilization of available academic resources.
6. In the event of any reserved category seat remaining vacant due to non-availability of eligible candidates, such seat may be filled from the Unreserved Category in accordance with prevailing Government norms and admission guidelines.
7. In order to promote access to Higher Education and enhance the Gross Enrolment Ratio (GER), all eligible applicants shall be accommodated to the maximum extent possible, subject to availability of seats and Government regulations in force.
8. All admissions shall remain provisional until verification of original documents and credentials. Admission obtained on the basis of incorrect information or forged documents shall be liable to cancellation.
9. Any matter arising out of the Spot Admission process and not specifically covered under these guidelines shall be decided by the concerned authority, whose decision shall be final and binding.

This notification shall come into force with immediate effect for Spot Admission, 2026.
